Applications and Surcharges:

- All visa application with dependants carries a surcharge of £300 + VAT per person. Dependant application from outside the UK carries a surcharge of £500 per person (VAT not included).
- 2. Request for further information on Admin Review carries a fee of £200 + VAT, if applicable.
- 3. All applications and works carried out for clients within the UK carry an additional 20% VAT.

Disbursements:

In addition to our basic charges we will also add, disbursements.
